



## NCDAA Opening Session/ General Assembly



64th Annual Session  
Friday, May 16, 2014  
Rita Millikan, CDA, President, Presiding

President Rita Millikan called our meeting to order at 2:10pm. Secretary Dianne Gwaltney called the roll and a quorum was present in order to conduct business of the association.

President Millikan took a few minutes to welcome everyone to our 64th Annual Session of the North Carolina Dental Assistants Association.

The Memorial Candle was lit by Kristy Eddleman, representing all NCDAA members who are no longer with us.

Judy Sigmon brought the invocation using her beautiful voice to sing "Sweet, Sweet Spirit."

Nanette Hill then led the Pledge to the Flag and the singing of our National Anthem. Everyone was asked to join in the reading of the Dental Assistants Creed on page 20 of the program booklet, and then the Dental Assistants Pledge on page 8.

President Millikan introduced our very special guests Lori Paschall, ADAA President, and Betty Gail Fox, ADAA 4th District Trustee, who brought greetings to us from ADAA. She then recognized all NCDAA Past Presidents and asked them to stand and introduce themselves and the year or years that they served. We had 9 Past Presidents in attendance. Life Members and Honorary members were also recognized. We had 7 Life Members present.

President Millikan made the following convention appointments: Hostess- Susen Darst, Photographer-Susan Wilson, and Timekeeper-Linda Clark.

The General Assembly is open to all members who are officially registered and who are wearing the official badge.


Secretary Dianne Gwaltney read the Rules to Govern the 64th Annual Session and moved for the adoption of these rules. A second was made by Judy Sigmon. All were in favor and the motion was approved.

Joyce Baker, Program Chairperson, presented the official program booklet for the 64th Annual Session.

Joyce made corrections and then moved for the adoption of the program as corrected with the right to make changes as necessary. The motion was seconded by Carol Sell. All were in favor and the motion was approved.

President Rita Millikan was recognized by Vice-President Joyce Baker and asked to give her President's address at this time.

All Committee reports are located on the table in the back of the room. These reports will not be read but will be placed on file with the secretary for any future reference.



Assistant Secretary Doris Clapp presented the Registration Report. Pre-registration- 209, On-site registration-16, Life Members-6, Honorary Members-2, Student Members- 25, Total Registration-257.

Deana Billings, Chairperson of the Judicial and Legislative Committee, did make an addition to her report concerning the vote coming before the NCDS House of Delegates on the Resolution about Expanded Functions for Dental Assistants and Hygienists.

Nominating Committee chair, Kristy Eddleman, presented the slate of officers for 2014-2016: President-Joyce Baker, Vice-President-Dianne Gwaltney, Secretary-Deana Billings, Assistant Secretary-Doris Clapp, Treasurer-Kristy Eddleman, and Immediate Past President-Rita Millikan. Qualifications for officers are on file.

There were no verbal reports from any of our local societies.

At this time in our program, Betty Gail Fox, 4th District Trustee, presented her report from American Dental Assistants Association, followed by comments from ADAA President Lori Paschal. Annual Session will be held in San Antonio, Tx, October 9-12, 2014.

Under new business, Nanette Hill, from Budget and Finance, presented the proposed budget for 2014-2015. Nanette recommended the following changes to the proposed budget. Line item #8 for \$100 will be deleted. Line item #25 for \$2536 will be decreased to \$1902. (Reason- we will only spend 3 nights, instead of 4 at Annual Session). Line item #43 will be increased from \$100 to \$450. With these changes, the proposed budget would total \$14,067.00. With no further questions, the budget was adopted for 2014-2015 with these changes.

Nanette Hill, chair of Bylaws/Manual of Procedures reported that she had sent all proposed amendment changes to the ADAA Bylaws Committee for review and approval. These have been approved and are being presented to NCDAA General Assembly today for adoption. Please note that the revisions are in "red". The recommendation of this committee was seconded by Deana Billings. All voted in favor of the proposed changes. The Manual of Procedures has also been revised and updated to incorporate these changes made by the NCDAA officers.

A motion was made and seconded to purchase " a hole " for the MOM's Golf Tournament to be held in Pinehurst on Aug. 11 for \$350.00. Motion was approved.

It was also suggested that following our November NCDAA Board meeting on Friday, Nov. 14, that we volunteer at the MOM's Clinic in Winston-Salem on Saturday, Nov. 15.

A special presentation and Honorary Membership to NCDAA was given to Prissy Allen during our afternoon General Assembly.



The slate of officers for 2014-2016 was presented by chair of the Nominating Committee, Kristy Eddleman. Since there was only one candidate for each office, a motion was made by Linda Clark and seconded by Susen Darst that we accept this slate of officers by acclamation. All voted in favor. New officers for 2014-2016 are President- Joyce Baker, Vice President-Dianne Gwaltney, Secretary-Deana Billings, Assistant Secretary-Doris Clapp, Treasurer-Kristy Eddleman, and Immediate Past President-Rita Millikan.

The final item of business to come before the House was resolution in support of the expansion of the role of dental assistants in N. C. This resolution was written by Deana Billings, was seconded by Carol Sell, and all voted in favor. Resolution passed.

Immediately following the business session, the annual awards were presented. Dianne Gwaltney, chair of the Awards Committee, announced these.

The Edna Zedaker Loyal Assistant Award was presented to Susan Wilson.

The William H. Oliver Achievement Award was presented to Rita Millikan.

The Ethel Earl Achievement Award was presented to Linda Kamp.

Kristy Eddleman presented the scholarship awards. The Faye Watkins Scholarship of Merit was presented to Katrina Knapp of Wake Tech.

The Edna Zedaker Scholarship was presented to Crystal Moore also of Wake Tech.

President Rita also expressed appreciation to all those who had contributed to planning Annual Session and for making it a success once again.

At the time the Head Table was vacated in preparation for the installation of officers.


Announcements were made which included the following:

## NCDA Executive Board Meeting

August 15, 2014

Joyce Baker CDA, President, Presiding

President Baker called the Executive Board of NCDA to order at 12:30 pm. There were 6 members present. Current correspondence was shared with the association including "Thank you's" from the NCDA Annual Conference. Joyce also shared how many states were not in compliance with their officers list, etc. This is concerning to the ADA and the membership.

Minutes from the May 16, 2014 meeting were emailed to all officers/advisor prior to today's meeting. These minutes were corrected. A motion was made by Kristy Eddleman and seconded by Dianne Gwaltney to approve. Motion carried.

Treasurer Kristy Eddleman reported that we currently have a balance of \$11,849.95 in our checking account. The Edna Zedaker Scholarship account balance is \$1,151.42 and the Faye Watkins Scholarship account is \$816.45. Kristy also reported that she has paid for the air fare and registration for the delegation to the ADA Annual Session.

Figures from the raffle was \$162.00 which goes into the Faye Watkins Scholarship and \$705.00 for the T-shirts. There were no other questions regarding the report; the report will be placed on file for audit.

Joyce read the report from our ADA Fourth District Trustee, Betty Gail Fox. She asked about a donation to be sent to the ADA. Kristy said she has already done this. In addition, all conference materials will be on line and ready 2 weeks before the annual session. Finally, in a move to reduce cost the ADA Journal will no longer be printed. You can get it electronically by going to the website.

### **STANDING COMMITTEE REPORTS:**

Deana Billings from Judicial/Legislative did not have a report. However, President Baker informed the group that she sent a follow-up letter to Dr. Richard Hunt for his help in getting our resolution presented to NCDS House of Delegates.

Bylaws/Manual of Procedure- Nanette Hill- No report.

Doris Clapp from Membership reported 222 active members, 324 e-members, and 213 students, giving a total of 759 as of June, 2014.

Nanette Hill from Budget/Finance had no report

Education : The report for Judy Sigmon was given by Joyce. She is still working on the November meeting. Tentatively we have scheduled Dr. Mark Shehan, Oral Surgeon, at Forsyth Tech in Winston-Salem. However, the date is still under consideration. It was suggested that November 7th be the first choice, November 21st second, and October 31st be the last choice.



We had a wonderful CE today presented by Debbye Krueger, RDH BS. The topic was “Public Health: Are You Looking at a Perapical or a Panorex”. The Past President’s Workshop had 11 people in attendance taking in \$350.00 and a donation from NCDAA of \$100.00. Expenses totaled \$404.80. This gave a profit of \$104.80.

**SPECIAL COMMITTEE REPORTS:**

Program: Rita Millikan had no report. However, President Baker discussed the agenda for the Annual Session in May 2015. It was decided that the only change would be to eliminate the Installation of Officers since we are now doing two year terms.

Awards: Dianne Gwaltney, chair, made the presentation of the William H. Oliver Achievement Award to Rita Millikan with her name now on the award which she received at Annual Session.

Convention: Dianne Gwaltney will contacted Kingston Plantation, Embassy Suites for the rooms needed. It was determined that we will have 2 Condos with 2 bedrooms and 1 Condo with 3 bedrooms. The agenda was discussed and everyone was in favor of doing the same thing this year. It was decided to only eliminate the Installation of Officers. The group discussed having all the food events in the Officers Suite. We spent \$3,441.90 for the May meeting in 2014.


President Baker read the E-Mail from Prissy Allen. Discussion occurred about the uncertainty of the amount that we may receive from NCDS for 2015 Annual Session. It was decided that President Baker would send a letter of appreciation to Dr. Davenport and Deana would send letters to Dr. Royce Porter and Dr. Evan Miller to promote good will and continued support equal to last year’s contribution. The money to be used by the Host for special guest doesn’t need to be increased.

Student Involvement: President Baker and Deana met with Linda Kamp to discuss how to get the students involved more. Joyce reported that the largest student delegation among schools was a non-accredited program, Lake Norman DA Program. She shared the schools and the number of student members at each. Forsyth Tech has a Student Chapter of the ADAA already. Joyce asked Linda to find out how many schools had clubs. It was determined that if the program already had a club it would be fairly easy for them to organize a Student Chapter. The next step is to contact the schools with clubs and ask them to form a chapter with NCDAA’s assistance. Joyce also mentioned that we need to relook at the NCDAA mentorship program to use it to assist and encourage students who get involved. The only concern addressed by Linda was that the information on forming a Student Chapter on the ADAA website was dated 2012 and needs to be revised before we send the schools to the website to get their materials. Nanette will try to contact someone about this.

Historical: Nanette no report. However, she shared pictures from our golf hole in Pinehurst in supporting the MOM projects.

Edna Zedaker Scholarship: The 2014 Award went to Crystal Moore, Wake Tech  
Kristy Eddleman reported was handed out, but no further action at this time.

Faye Watkins Scholarship: The 2014 Award went to Katrina Kapp, Wake Tech.  
Money raised at NCDAA Annual Session was \$162.00. Amanda Myers –No additional report.



NC Committee for Dental Health: Nanette reported the following points:

- NC Oral Health Collaborative is very interested in have NCDAA be a part of it.
- Mr. Alex White is the new Director of the UNC Gillings School of Public Health.
- UNC School of Dentistry announced they have 17 new faculty members, the entering class has been increased to 82, and there are some changes to the 3rd year curriculum for the dental students.
- ECU School of Dentistry will have its 4th class entering this fall. Seven Community Service Learning Centers are operating.
- BCBS Foundation continues to look for grant opportunities and are wishing to engage the Spanish Community in using fluoridated water.
- NC Oral Health Section is working on early childhood programs and hiring several dentists.
- NC Division on Aging and Adult Services are concerned about Medicaid cuts for adult care homes and elder abuse.
- NCDS is working on a elder care initiative, school based sealant program from the Institute of Medicine, ED referral program, broadening the scope of practice for RDHs and CDAs, Young Dentist Leadership Academy, reviewing sedation standards, the Supreme Court FTC vs NC Board of Dental Examiners case, NC MOM projects, and keeping the 2 dentists in the Senate and the 1 in the House informed and challenged to provide support for organized dentistry in the NC.

### SANDHILLS DENTAL ASSISTANTS SOCIETY


The Sandhills Dental Assistants Society took the months of July and August off. We installed our new officers at our June meeting. Our officers for 2014-2015 are as follows:
